SAS4011Topic for Autumn 2011: Buddhist political culture

The idea that Buddhism and politics are mutually exclusive categories, the one oriented in an otherworldly direction and the other concerned with social organization has become commonplace. This separation is often assumed not only by Western observers, but often also by Buddhists themselves, claiming that the mixing of the Buddha's Teaching, the *dharma*, with politics is a corruption of the Buddha's original message. However, history shows a close relationship between Buddhism and state power, indicating certain Buddhist ideas of the 'political'. These ideas and practices have been subject to change, and particularly modernity and modern party politics have posed challenges to the Buddhist monastic order. An interesting case in point is the historic entry of the All Monks Party to the Sri Lankan Parliament in 2004. Did their entry represent a radical change from tradition and how did other sections of the Buddhist community respond? To explore the relationship between Buddhism and politics, we will read several historical and ethnographic studies on Sri Lanka, but relevant questions regarding other Buddhist polities will also be addressed.
