#### Introduction

The GLOBUS Data Management Plan (DMP) ensures that the data handling within the project is both legally and ethically correct and methodologically sound, and that personal data used in the research complies with the EU General Data Protection Regulation (GDPR), which entered into force on 25 May 2018. The plan describes the types of data that are generated and collected during the project, the standards used, how the data will be exploited and shared, as well as the preservation and storage of data.

The DMP evolves during the lifespan of the project. The DMP and information on each dataset will be updated at regular intervals (v1-v5: months 8, 13, 20, 31 and 48).

The GLOBUS DMP is based on the template for the H2020 Data Management Plan v1.0 (13/10/2016). It follows the Horizon 2020 guidelines on Data Management and Open Access to Scientific Publications and Research Data as well as the general principles for FAIR data management (Findable, Accessible, Interoperable, Re-usable).

The first part of this DMP (sections 1-6) outlines GLOBUS' data management policy in terms of data gathering, storing, archiving and sharing, as well as relevant ethical issues. The second part (section 7) contains detailed information on relevant data management issues for each dataset generated by the project.

## 1. Data Summary

## 1.1 Project objectives

Reconsidering European Contributions to Global Justice (GLOBUS) critically examines the European Union's contribution to global justice. Combining normative and empirical research, the project studies the contents and conduct of the EU's external policies with a particular focus on climate justice, migration, trade and development regimes, peace and conflict resolution, gender and human rights. It involves scholars from several disciplines: politics; international relations; philosophy; economy; law; and sociology. The research is conducted within five thematic work packages: WP1 Global Political Justice; WP2 Climate Change and Global Justice; WP3 Migration and Global Justice; WP4 Trade, Development and Global Justice; WP5 Security and Global Justice.

# 1.2 Data types and formats

GLOBUS researchers conduct social science research that first and foremost involves generating <u>new data</u> in the form of semi-structured interviews with experts, government representative, EU and member state officials, EU representatives and officials from third countries, representatives from NGOs and international organisations. This is an open interview form based on an interview guide with an informal grouping of topics and questions to be adapted to the interview setting, allowing new ideas to be brought up during the interview as a result of what the interviewee says. In some cases, interviews are audio recorded and stored as audio files. In most cases, however, the interviews are not recorded due to the sensitivity of the issues and the risk of key informants not speaking frankly and openly about the questions at hand if the information is recorded and potentially distributed to others. This data consists in interview notes in the form of text files (see details on formats in section 2.3).

GLOBUS researchers also collect and analyse existing data in the form of publicly available documents. This includes official documents, speeches and statements, policy documents, parliamentary and media debates, as well as public polling data. Individual researchers

reference the original data in the relevant publications. Generally, documents are collected online from publicly available websites and databases, and information on the databases that have been searched and information on how to access them will be provided in the academic publication. These same overviews will also be archived. Some data (for example online media debates), although publicly available, may after some years either be deleted or difficult to track, or they are not available through searchable databases (for example official documents retrieved through freedom of information requests). A researcher may for such reasons create a dataset with fulltext versions of the documents which is made available open acess, while ensuring compliance with the GDPR (when dealing with personal data) and copyright regulations.

## 1.3 Expected volume of the data

The size of the data collected in this project is limited, and mainly in the form of text files. The volume of each dataset has been estimated based on information on file formats and expected volume (e.g. number of planned interviews x average duration + quality of the format and the number of intermediate versions). In most cases the size is larger in the active phase (storage) than in the archiving phase (deposit). See more in section 7 below for details per dataset.

## 1.4 Data utility

Data generated and collected by GLOBUS researchers would be useful for the broader scientific community for the sake of validating results presented in GLOBUS's scientific publications. Some of the collected data such as media debates and official documents may also be useful for future social science research. In the case of anonymised interviews, these are unlikely to be useful for future research by a third party. The relevance of the information that they contain cannot be assessed unless the data processor has some idea of the institutional affiliation of the interviewee. In order to be considered reliable, the information provided by one interviewee also needs to be cross checked with information from other interviewees representing different institutions and different interests. Such cross-checking is not possible with anonymised interviews. Finally, interviews will be semi-structured and geared towards a specific research question rather than take the form of open-ended surveys of a set of actors' views or experiences with regard to a broader theme. The information that they contain is thus unlikely to be relevant for third parties.

#### 2. FAIR data

# 2. 1. Making data findable, including provisions for metadata (F)

### **Persistent identifiers**

All GLOBUS datasets will upon archiving in a repository be assigned a persistent identifier (PID) in the form of a unique and permanent URL (Uniform Resource Locator) or DOI (Digital Object Identifier). As a general rule, GLOBUS datasets will be archived in the Norwegian Centre for Research Data (NSD) repository, which assigns and use a permanent URL as a PID.

#### Naming conventions

GLOBUS datasets will be named as follows: GLOBUS-WPX[work package number]-oo[number of the dataset in this WP]-Name[last name(s) of the researcher(s) in charge]-datatype [interview, other].

#### Metadata

All datasets will be described with metadata – a common set of characteristics or attributes of the data – to allow for discovery and analysis and to support effective data sharing. GLOBUS will use the Data Documentation Initiative (also known as DDI or DDI Metadata) international standard which is well suited for describing social science research information. This standard is used by NSD for their data archives.

The DDI standard will be complemented with some metadata terms from the Dublin Core Schema to allow for more refined metadata. All GLOBUS datasets will, as a minimum, be described according to these terms:

- Project information
- Data title
- Responsible researcher\*
- Data type
- Keywords\*
- Description
- Language

Methods

Collection period

- Versions
- Size\*
- Is the data person-identifiable?
- Publications based on the data
- Access rights\*

Thematic search keywords will be provided to optimize possibilities for re-use.

The data owner will assign a version number from Vo.1 to Vo.9 to each dataset when the data is still being used (storage phase). The final deposited data will be given the version number V1.0 (archive phase). Any changes made to the dataset after deposition are logged in the repository's version control system.

# 2.2. Making data openly accessible (A)

#### Repositories

After the end of the project (31/05/2020), and as soon as the project results have been published in the form of peer-reviewed publications, the GLOBUS datasets will be deposited with the Norwegian Centre for Research Data (NSD). NSD is one of the world's largest research data archives and ensures safe and sustainable storage. This repository is available to all GLOBUS researchers regardless of their institutional affiliation. Upon deposition, the data supplier (GLOBUS researcher) and NSD will sign an archiving agreement, which regulates the terms and conditions for archiving and making research data accessible:

#### Access to data

Considering the research questions at hand, some of the raw data generated by semi-structured interviews with high-level diplomats and policy makers, will need to be treated with confidentiality. Some interviews will not be recorded due to the sensitivity of the issues and the risk of key informants not speaking frankly and openly about the questions at hand if the information is recorded and potentially made available to others. Other interviews may be recorded, but the audio files will not be made available to others. Such off-the record interviews are relevant in cases where the person would not allow the interview to take place should the information be made openly accessible. The interviewees speak frankly about their institutions' assessments with regard to potentially sensitive political issues as well as about their relations with representatives of other institutions and countries.

In cases where there is a risk that the interviewee could be identified (i.e. due to the small number of people in similar high-level positions) or in cases where the appropriate level of anonymisation entails that the interview data would lose its value for other researchers, third parties will not be given access neither to raw data nor interview notes.

Less sensitive interview data will either be recorded and transcribed, or interview notes will be taken. Based on a cost-benefit analysis, the researcher will decide if anonymisation or pseudonymisation of data is appropriate in order to allow for reuse. In most cases, pseudonymisation, or de-identification, is the relevant means of mitigating the ethical concerns arising from the use of personal data, as it gives the researcher generating the data the opportunity to re-identify the interview objects. In line with GDPR Art. 6(4), pseudonymised data may be used beyond the purpose for which the data was originally collected, and data subjects' rights to data access, rectification, or erasure no longer apply. Anonymisation entails that it is no longer possible to identify individuals in a dataset, even by the party responsbile for the anonymisation, and will due to the nature of the data be less relevant for GLOBUS researchers. Depending on the nature of the data, and the consent given by the data subjects, interview data will be made available to third parties either open access or with restrictions. In the latter case, access will be granted by agreement with the data owner (researcher), and only for the purpose of scientific research, on the basis of a signed loan agreement with the repository. The GLOBUS website will make reference to datasets used in project publications, by linking to the data repository (persistent identifier).

If a collection of full-text documents is made available to third parties, the researcher will make sure to comply with copyright and GDPR regulations. If any of the latter entails that the raw data cannot be deposited, the dataset will consist in an overview of documents identified and a reference to how/where they could be accessed at the time of deposit.

## 2.3. Making data interoperable (I)

The data to be deposited and made available for other researchers will be archived in standard formats and in compliance with available open software applications to allow for data exchange and reuse. The file formats for the different kinds of data are listed below. By using DDI and Dublin Core as metadata standards the interoperability within the European Open Data Space is guaranteed.

## 2.4. Data re-use (R)

Data that is made available for re-use will be so after the end of the project (31/05/2020), or when the project results have been published in the form of peer-reviewed publications. The latter may entail a later date for re-use of data than the end of the project period due to delays in publications in many scientific journals.

Project-generated data will be made available under a Creative Commons license, which manages copyright and the terms and conditions for access and reuse. A CC licence requires attribution of the licensor (data supplier) when the use involves public shareing.

### 3. Allocation of resources

### 3.1 Costs

Costs related to overall data management activities are limited, as this an integral part of the management of research activities of all GLOBUS researchers. Data management activities at the consortium level is an integral part of Work Package 9 Coordination and Management. No specific funds have been set aside for this, other than the relevant salary costs for the Scientific Coordinator and the Project Manager.

All interviews will be conducted under the promise of anonymity/confidentiality as the substantive areas of analysis include what we define as sensitive issues. When possible, interview notes and transcripts will be pseudonymised so that single respondents cannot be identified, and then made available for open access. The degree to which datasets will be openly accessible is in some cases dependent on the costs related to anonymisation. As the costs of pseudonymisation/anonymisation can be high, and each GLOBUS partner institution will make an assessment of the potential benefit to other researchers of making datasets available, compared to the estimated costs involved. For each data set below, we have estimated such costs. If the datasets are considered to be of high value to other researchers also when anonymised, the partner in question will consider spending GLOBUS funds to ensure anonymisation. The question of costs for long-term preservation of data is not relevant, as archiving of data with the NSD (and similar repositories) is free of charge.

# 3.2 Data management responsibilities

The GLOBUS Executive Board – consisting of the GLOBUS work package leaders – is responsible for the project's data management policy and open access policy. The GLOBUS Coordinator Helene Sjursen handles the implementation of this policy, with the aid of the GLOBUS Project Manager. All GLOBUS researchers are responsible for their datasets and for complying with the terms of this DMP as well as their own institution's data management policy and ethical regulations.

# 4. Data security

All data generated – regardless of the need for confidentiality – will be safely stored both during the analysis phase (phase I) and during the preservation phase (phase II). During Phase I (Storage), when researchers actively use the data, it will be stored in personal password-protected spaces on secure university servers, which provide appropriate back-up solutions. Data may be stored preliminarily on personal computer hard drives, laptops and/or on paper, but will be transferred as soon as possible to secure servers .

In Phase II (Archiving), when the researchers' project specific use of the data has finished, data will be deposited for long-term storage in a certified repository, most notably the NSD (Norwegian Centre for Research Data) which offers a free high-quality service.

## 5. Ethical aspects

Ethical issues related to the data collection and management is described in the GLOBUS Description of the Action (DoA). It is the responsibility of the data collecting partner to ensure compliance with ethics requirements of his/her home institution and country.

The main ethical aspects in GLOBUS relate to humans as participants in research mainly through interviews. The interviewees will be experts, government representatives/civil servants as well as policy stakeholders selected on the basis of their position within institutions or organisations that have insights into the EU's policies on global justice. Only the summary findings from the interviews will be made publicly available through the scientific publications of the project. Interviewees will not be speaking of their private experiences or even speaking in a personal capacity, but as representatives of an institution. All interviewees will receive the same information prior to the interviews, including an explanation of the purpose of the interview, the anonymity guarantee, and plans for publication of results. Personal data will be treated in line with GDPR until the moment of anonymization when there will be no long-term stored links between the personal data (name/affiliation/position) and the interview data. Most GLOBUS researchers will want to keep the possibility of re-identifying their interview data for use in line with the premises for the interviews and use of this data.
