Register with the police



Nordic citizens

• You do not need to register with the police

EU/EEA citizens

• You will meet with the police to be issued a Registration certificate

Non-EU/EEA citizens

• You will meet with the police to be issued a residence permit card

Police registration for EU/EEA-citizens

Register after arrival in Oslo

- If you are staying for more than 3 months, you must register with the police within 3 months after arrival
- •Fill in the online application form on the <u>UDI web page</u>
 - Fill in ALL your names as in your passport/National ID card

- •You can only book an appointment with the police after arrival in Oslo
- •Book the first available appointment with the police
 - Choose «Oslo police district, Service Center for foreign workers" (SUA)
- •Register your Oslo address and room number
 - Contact SiO housing about registering your postal address

EU/EEA-citizens: Documents

- •You can study and stay in Norway while waiting for the police appointment
- •Remember to make a copy of the IDdocument you used for the online registration
 - Bring a print-out from UDI's web page that proves you have registered an application
- If you have a letter of conditional admission, you can submit this to police

EU/EEA-citizens: Norwegian ID number

Report move to Norway

• If staying for 1 semester you are not eligible for a Norwegian ID number

•Exemption:

 If you find a job and register for a tax card, you will receive a D-number (temporary ID number) Only for students staying more than 6 months (2 semesters or more)

After the appointment with the police at SUA (Service Center for Foreign Workers) you will be transferred to the Tax Office

Bring the completed form <u>RF-1401 Report</u> <u>a move to Norway from abroad</u> and your tenancy contract

The Tax Office will issue a Norwegian ID number

Police registration for non-EU/EEA citizens

If granted a study permit before arrival

- •You will meet with the police to be issued a residence permit card
- •Book an appointment with the police on the <u>UDI's web page</u>
 - Choose "Oslo Police District, Department of Immigration"
- If unable to book an appointment online, you may contact the police by calling: (0047) 22 34 21 00

For your police appointment you must bring



Residence permit for non-EU/EEA citizens

If you have not obtained a study permit

- •Some students can travel to Norway and hand in the application for residence permit after arrival
- •Make sure you fulfill the requirements to apply from Norway
 - If you are uncertain, please contact UDI directly regarding your specific case

Applying for study permit after arrival in Norway

Submit an online application and book an appointment on the <u>UDI web page</u>

Bring with you all required documents to the police appointment

See the <u>UDI checklist</u> for documents to be handed in

Follow the UiO guide for how to apply for residence permit

Non-EU/EEA citizens: Norwegian ID number

- •You will register for a Norwegian ID number at the same time as you meet with the police
- •The police will notify the Tax Office (Skatt Øst) on your behalf

- •The Tax Office will send you a letter with a Norwegian ID number
 - D-number (if staying 1 semester)
 - National identity number (if staying 2 semesters or more)
- •Important to inform the police of your address in Oslo and room number
 - Contact SiO housing about registering your postal address

Renewal of residence permit

Progress report

- •Non-EU/EEA students must apply for renewal of residence permit before your current permit expires
 - Full-degree students (bachelor and master) staying in Norway for more than one year
 - Exchange students who will extend their stay at UiO
- •The application must include a <u>progress</u> <u>report</u> – statement of your study progress
- •You can request a progress report from Knutepunktet



Health insurance

EU/EEA citizens

- •You must have health insurance from your home country:
 - EU health insurance card or
 - Private health insurance
- •Must be valid for the entire study period in Norway

Non-EU/EEA citizens

- •You can become voluntary member of the National Insurance scheme
 - Must submit an application if you are staying 3-12 months
 - Students staying for more than 12 months will be automatically registered
- It can take months to be registered with the National Insurance Scheme
 - We recommend private health insurance while waiting to be registered

Part-time work as an EU/EEA citizen

- •No restrictions on the amount of work while studying
- •You can start to work before the appointment with the police
- If offered a job, you must register with the tax office




Work permit for non-EU/EEA citizens

Work permit and UDI

- •The part-time work permit as a student only allows you to be an employee
 - You are therefore not allowed to set up your own business (sole proprietorship enkeltmannsforetak) while you are on a student permit
- If offered a job, you must register with the tax office





The part-time work permit has the same duration as the study permit



You can start to work after you have received your residence permit

Work and tax in Norway

Tax Office – Skatt Øst

- •You can apply for a tax card when you have a work contract
- Book an appointment with the Tax Office (Skatt Øst) to order a tax card
- •Contact information:

Opening a bank account

Staying for 1 semester (less than 6 months)

- •Most likely not an option without the Norwegian ID number
- If you receive a D-number:
- •Visit the bank of your choice and ask for the service to open a bank account

Staying for 2 semesters or more

- •After you have received your National identity number:
- •Visit the bank of your choice
- Processing time can be several weeks
