

# Before arrival: Apply for residence permit

Non-EU/EEA citizens

- •If studying in Norway for more than 3 months, you must have a student residence permit
  - Also applies if you have a residence permit in another Schengen-country
- Submit an online application on the UDI web page
- Follow <u>our guide</u> for how to apply for residence permit

Applying from abroad

- •Students who need an entry visa must apply for residence permit before arrival
  - If applicable, you apply for entry visa at the same time
- Hand in all required documents to the embassy/consulate/VFS by 1 July
- See the <u>UDI checklist</u> for documents to be handed in

## Applying for residence permit after arrival in Norway?

- Some students can travel to Norway and hand in the application for residence permit after arrival
  - Exchange students on bilateral or Erasmus+ agreement who do not need an entry visa
- Make sure you fulfill the requirements to apply from Norway
  - If you are uncertain, please contact UDI directly regarding your specific case

- Submit an online application and book an appointment with the Oslo Police Department on the <u>UDI web page</u>
- You can book an appointment before arrival in Norway

# Pilot project with the UDI

- •A small group of bilateral exchange students have been invited to participate in a pilot project with the UDI
- You will apply for residence permit upon arrival
- Separate dates with the Oslo Police Department

- The exchange students who have signed up to participate will **not** apply through the UDI web page or hand in documents

## Documents from UiO

Documentation of admission and housing

- You will find the Admission and Study plan letter in UiOs Søknadsweb
- •Will cover certain requirements from UDI regarding:
  - Admission
  - Housing

Documentation of financing

 Check your Study plan letter if there is a confirmation from UiO that you have sufficient financial means to cover your living expenses in Norway

- If yes, you do not need to make a transfer of funds to SiO deposit account
- If no, you must make a transfer of funds to the SiO deposit account in order to document financing

# SiO residence permit deposit account

Transfer of funds

- Only for bilateral exchange students who need an entry visa to Norway
- Apply for SiO's UDI Deposit Account
  - Remember to write all your names
  - If possible, make the transfer i Norwegian kroner (NOK)
- Recommended deadline: 15 June
  - You will receive a confirmation letter on SiO Mypage

Access to your funds after arrival

- After arrival in Norway, you will have access to your transferred funds
- You can pay your housing rent with the funds, if living in SiO housing
- Contact SiO Accounting Office to receive reloadable debit card

# Upon arrival: Register with the police

Non-EU/EEA citizens

- You need a student residence permit to stay in Norway
- Book an appointment with the police to register your arrival
- You can book an appointment before arrival

**EU/EEA-citizens** 

- You must register with the police if staying for more than 3 months
- Only need to register once
- Book an appointment with the police after arrival

Nordic citizens

Do not need to register with the police

# Police register for non-EU/EEA citizens

- You must meet with the police to be issued a residence permit card
- You can book an appointment before arrival on the <u>UDI web page</u>
  - Choose "Oslo Police District, Department of Immigration"
  - If unable to book an appointment online, please contact the police for assistance

For your appointment you must bring

- Passport/National ID card
- Your address in Norway (on a piece of paper) with the housing unit number
- Receipt from SiO residence permit deposit account (if applicable)

 Your residence permit card will be sent to your Oslo address by post

## Police registration for EU/EEA citizens

- You need to register with the police within 3 months after arrival
- Book an appointment after arrival in Oslo
- •Fill in the online application form on the UDI web page
  - Select «A SUA Office»
  - Choose "Oslo Politidistrikt, Servicesenteret for utenlandske arbeidstakere (SUA)"
  - Fill in ALL your names as in your passport/National ID card

Documents you must hand in to the police

- The ID-page of your passport or both sides of your National ID card
- EU Health Insurance Card or private health insurance documents (valid for the entire study period)
- Admission letter from UiO
- Declaration of funds a personal statement that you can support yourself

 You can stay in Norway and study while waiting for the police appointment

## Health insurance and travel insurance

### All students should have travel insurance while studying in Norway

#### EU/EEA citizens

- You must have health insurance from your home country:
  - EU health insurance card or
  - Private health insurance

 Must be valid for the entire study period

#### Non-EU/EEA citizens

- You can become voluntary members of the National Insurance Scheme
- Must submit an application if staying
  3-12 months
  - It can take months to be registered with the National Insurance Scheme
  - We recommend private health insurance while waiting to be registered

## Norwegian ID number

#### EU/EEA citizens

- Staying for 1 semester:
  - You are not entitled to a Norwegian ID number
  - Only if you find part-time work, will you get a temporary ID number when applying for a tax card
- Staying for 2 semesters:
  - You must register with the National Registry if staying for more than 6 months
  - If you have an appointment with SUA, you will be transferred to the Tax Administration

#### Non-EU/EEA citizens

- You will register with the National Registry (Tax Administration) at the same time you meet with the police
- The Tax Administration will send a letter with a Norwegian identification number
  - D-number (1 semester)
  - National Identity number (2 semesters)
- The letter will be sent to the address you gave to the police
  - Important that you notify the police if you change your address

## Bank account

Staying for 1 semester

 Almost impossible to open a Norwegian bank account if staying in Norway for six months or less

 We recommend that you bring with you a credit card (visa/master) that can be used in Norway/Europe during your stay in Norway

#### Staying for 2 semesters

- After receiving your Norwegian ID number, you can open a bank account in Norway
  - Can take some time to open a bank account
  - If appicable, apply on SiO MyPage for a refund to get your funds on SiO deposit account transferred
