Participant Biographies

Gish Amit (Ben-Gurion University of the Negev, Israel)

Gish Amit is a PhD student and a lecturer in the Hebrew Literature Department at Ben-Gurion University. His work is an inquiry into the history of the Jewish National and University library, in the context of Israeli nation-building and the development of Israeli culture. The dissertation focuses on three affairs: the transfer to Israel of Holocaust victims' books, the collection of Palestinian libraries during the 1948 War and the appropriation by the state of books that had belonged to Jewish immigrants from Yemen.
