ENG2166 and ENG4166: Middle English, an introduction

Textbook:

- (- For each student, 100 pages of additional secondary literature selected by the student for their individual qualifying papers; this literature is discounted as far as the required reading for the exam.)
- A compendium of Middle English texts extracted from various printed sources.

The written exam tests the below learning outcomes as specified in: https://www.uio.no/studier/emner/hf/ilos/ENG2166/

- understand the background for the linguistic situation in England in the period 1100–1500 AD:
- know the linguistic structure and characteristics of Middle English;
- have gained a basic knowledge of Middle English dialects and dialect features;
- be able to localise Middle English texts from their spelling and other linguistic features;
- be familiar with the written record of the Middle English period;
- know the principles of manuscript studies;
- understand the processes at work in the standardisation of English.

There are two individual qualifying papers. At least one of the two will typically follow the format of the exam.

The examination format is a final 4-hour unsupervised written test. The student is instructed always to write in grammatically complete sentences and to refrain from producing single-word answers. The test consists of a series of questions in two parts. The Part 1 questions invite shorter answers, while the Part 2 questions invite essay-type answers. The Part 1 questions may include a short translation question. Some of the questions will be based on a Compendium text.

The student's written English proficiency contributes to the final mark. It is usually employed in an adjusting function if the examiners are in doubt about the most suitable mark for the contents, such that a high level of proficiency will raise the mark and a low level of proficiency will lower the mark.
