The Nordic countries are generally rated highly in regards to press freedom. In the article «Freedom of Expression and the Professionalization of Journalism» Arne Krumsvik states:

Freedom of expression and media plurality has been the two main objectives of Norwegian media policy, and the state's responsibility to create conditions that facilitate open and enlightened public discourse was written into the Constitution in 2004. This provided a justification for the use of different policy measures to guarantee a degree of media diversity it is often assumed the market would not be able to provide on its own. (Krumsvik 2013)



However the current Nordic media policies have come under pressure, as Hjarvard and Kammer state:

The Nordic countries' media systems are exemplary of the democratic corporatist model, and newspapers have occupied a very prominent position in the political public sphere supported by wide circulation and a political will to subsidize the press and still keep an arm's length distance. During past decades, these features have come under pressure due to – among other things – the spread of digital media. (Hjarvard & Kammer, 2015)

Based on the above statements and readings from the syllabus, assess and discuss whether current challenges to the Nordic media systems are also challenges to freedom of expression and media diversity.
