### **AVAILABLE INTERNSHIPS 2018**

For the purposes of HUMR4504, there are three categories of internships:

- One, pre-arranged internships, mainly our internal NCHR internships, but also with some external partners. Here the host institution has committed to receive one (or more) of our student(s). Based on current information, it seems that there will be approximately 15 pre-arranged internships in 2018. To apply for these internships, please submit the application form posted on the course website to Peris Jones, p.s.jones@nchr.uio.no. Application deadline: Friday 2nd February at 13:00!
- Two, pre-approved internships. These are internships which are available through open, public competition, but which are pre-approved in the sense that you if you obtain any of these internships, you are guaranteed to have the internships approved for the course. Please note that if an institution is missing on the list below, this does not suggest any presumption that the institution will not be approved only that we have had no previous dealing with them in this course. To apply for these internships, follow the procedures for the relevant internships. If you obtain such an internship, please contact the course coordinator at the earliest opportunity. If you don't have such an internship confirmed before the application deadline for the pre-arranged internships, please submit an application for the pre-arranged internships as well.
- Three, internships which are available through open, public competition or through private initiatives, but which are not pre-approved by us. You are most encouraged to find an internship with other institutions than those we have listed, but if you do, you must apply to the course coordinator to have the internship approved for the course. If you obtain such an internship, please contact the course coordinator at the earliest opportunity. If you don't have such an internship **confirmed and approved** before the application deadline for the pre-arranged internships, please submit an application for the pre-arranged internships as well.

# THE NORWEGIAN CENTRE FOR HUMAN RIGHTS, THE INTERNATIONAL DEPARTMENT

The NCHR International Department has an extensive network of cooperating partners, including academic institutions, UN organs, state institutions, and civil society organisations. Vietnam, Indonesia and China have historically been prioritised countries. The International Department's work is structured around the following 6 themes, with possible internship options corresponding, as follows:

- Human Rights Education
- Rule of Law
- Freedom of Religion or Belief
- Human Rights and Business
- Equality and non-discrimination
- Human Rights Mechanisms

Examples of possible internships include:

#### INTENSIVE COURSE IN INTERNATIONAL HUMAN RIGHTS

The intensive course will be held 3-7 September 2018, but preparations will start early this year. In 2018, the course was attended by participants from Iran, Uganda, Norway, Indonesia, China, Vietnam, Cuba, Palestine, Bolivia, Myanmar, Georgia, Iraq and Colombia. Some were working for government ministries, while others represented civil society organizations, law offices and academia.

The intern will work with preparation of the course, including assisting in designing the course schedule, communication with applicants and lecturers, shortlist applicants for travel grants, preparing logistics (travel and all related aspects), preparing reading materials, distribution of information through web and other channels, help with running of the course itself (for example, accompanying participants to institutional visits at the Supreme Court, National Human Rights Institution etc.), and assessment of the course.

#### **HUMAN RIGHTS MECHANISMS**

To reduce the 'implementation gap' in human rights, the NCHR works to increase the civil society awareness of the work conducted by the OHCHR and the UN Human Rights Council (HRC) in order to make state authorities honour their human rights obligations. The NCHR supports academics and representatives of civil society from our partner countries to participate as independent observers during UN human rights hearings. During 2017-2019, the NCHR will attend UPR hearings of Indonesia, China, Vietnam and Iran. Possible tasks for the interns will be assisting in developing activities for the UPR hearings, desk study reports, writing and/or editing, participation in ongoing activities /seminar and other administrative tasks. The intern will be based in Oslo but with opportunities for international travel.

#### **EQUALITY AND NON-DISCRIMINATION**

### RULE OF LAW/ANTI-TORTURE AND POLICE REFORM

NHCR works in several countries with the aim of improving the human rights compliance of police forces, preventing torture, and averting wrongful convictions, through the introduction of the non-coercive interrogation technique known as "investigative interviewing". We also work through multilateral channels with the aim of developing global standards for police interviewing.

The intern will participate in ongoing programme activities related to the above-mentioned topic, such as preparing and co-organising project activities (trainings), report writing and/or editing, developing teaching materials, as well as other administrative and topical tasks. # SHAPE SEA BANGKOK/HUMAN RIGHTS EDUCATION

NCHR is supporting human rights education at university level in Southeast Asia through SHAPE SEA, a human rights research network. The aim of this cooperation is to promote human rights education in line with strict academic, as well as international human rights standards, and to disseminate such education throughout the ASEAN countries.

One internship is available in association with the Shape Sea. The intern will be based at the Institute of Human Rights and Peace Studies, Nakronpathom, Mahidol University, Thailand. Preferable length of internship for 2-3 months. The intern will conduct desktop reviews, draft policy briefs based on research reports, assist in organising seminars and visits, support day to day activities and participate in ongoing activities. More specific tasks may be assigned upon initiation of the internship in dialogue with the intern. # THE NORWEGIAN CENTRE FOR HUMAN RIGHTS, TEACHING COOPERATION WITH THE LAW SCHOOL OF YUNNAN UNIVERSITY, CHINA

The China Autonomy Programme (CAP) was a thematic programme at the NCHR that ended in 2015. One of CAP's activities, for more than a decade, was to run a partnership with a number of Chinese institutions within teaching, education and research. The partnership with the Law School of Yunnan University (LSYU) continued in 2016 and is scheduled to continue also in 2018, and this partnership requires two interns for 3 months during the spring semester. The interns will be based in Kunming, China. Their tasks will include providing teaching assistance, including papering seminars, collecting documentations when needed; conduct research on rights issues of minorities in China, documentation collection and organization; and other work tasks include preparing for guest lectures and main lectures. Until 31 December 2016, NORDEM was based at the Centre, but it was transferred to the Norwegian Refugee Council as of 1st January 2017. NORDEM's main objective is to enhance the capacity of international organisations working in these fields – such as the OSCE, the UN and the EU. The tasks of the interns may include supporting NORDEM in arranging pre-mission briefings: identifying thematic/country experts relevant for the assignment and collect relevant background information on the political/human rights situation in the country of assignment; assisting in the deployment process of personnel to election or human rights missions with the OSCE, the UN, the EU or other organisations; assisting in arranging human rights and election observation trainings or seminars; and providing general support to the NORDEM secretariat. Interns will be based in Oslo.

In relation, the intern's time in regard to the socio-economic right to water and may also be shared with the Katiba Institute (KI), also located in Nairobi. KI is a legal rights NGO, established in 2011 to promote knowledge and studies of constitutionalism and to facilitate the implementation of Kenya's new constitution. The principal objective of KI is to achieve social transformation through the constitution. KI works to help promote the implementation of the constitution through diverse areas including issues of leadership and integrity, human rights, devolution, gender and electoral issues, appropriation of land and evictions of indigenous people and other long term settlers and protection against illegality and harassment by the police, facilitating public participation
