For the purposes of HUMR4504, there are three categories of internships:

- One, *pre-arranged* internships, mainly our internal NCHR internships, but also with some several external partners. Here the host institution has committed to receive one (or more) of our student(s). To apply for these internships, please submit the application form posted on the course website. **Application deadline: Wednesday 29 January at 13:00!**
- Two, *pre-approved* internships. These are internships which are available through open, public competition, but which are pre-approved in the sense that you if you obtain any of these internships, you are guaranteed to have the internships approved for the course. Please note that if an institution is missing on the list below, this does not suggest any presumption that the institution will not be approved only that we have had no previous dealing with them in this course. To apply for these internships, follow the procedures for the relevant internships. If you obtain such an internship, please contact the course coordinator at the earliest opportunity. If you don't have such an internship **confirmed** before the application deadline for the pre-arranged internships, please submit an application for the pre-arranged internships as well.
- Three, internships which are available through open, public competition or through private initiatives, but which are not pre-approved by us. You are very encouraged to find an internship with other institutions than those we have listed, but if you do, you must apply to the course coordinator to have the internship approved for the course. If you obtain such an internship, please contact the course coordinator at the earliest opportunity. If you don't have such an internship **confirmed and approved** before the application deadline for the pre-arranged internships, please submit an application for the pre-arranged internships as well.

PRE-ARRANGED INTERNSHIPS

#1 International Department at the NCHR

The NCHR International Department has an extended network of cooperating partners, including academic institutions, UN organs and civil society organisations. Though Vietnam, Indonesia and China will continue to be prioritized countries, the International Department's work will also be structured around 6 cross cutting themes:

- Human Rights Education
- Rule of Law
- Freedom of Religion or Belief
- Human Rights and Business

- Equality and non-discrimination
- Human Rights Mechanisms

The implication for the Department's work, and therefore Internships, is that the programme activities are no longer tied only per country focus but in addition will now also take into consideration these thematic areas, which may work across countries, regionally and even through global/UN mechanisms.

1.1 Human Rights Mechanisms (1 Internship available)

To reduce the implementation gap the NCHR works to increase the civil society awareness of the work conducted by the OHCHR and the UN Human Rights Council (HRC) in order to make state authorities honour the human rights obligations. The NCHR support academics and representatives of civil society from our partner countries to participate as independent observers during UN human rights hearings. The NCHR will observe UPR hearings of relevant countries. Possible tasks for the interns will be assisting in developing activities for the annual UN Human Rights Mechanisms training in Geneva (May), UPR hearings, desk study reports, writing and/or editing, participation in ongoing programme activities /seminar and other administrative tasks. The intern will be based in Oslo but with opportunities for international travel. We seek a motivated student with an interest in the UN and human rights mechanisms, strong English language skills and writing ability. 1.2 Equality and Non-Discrimination (2 Internships available)

The NCHR works to support the achievement of the equality and non-discrimination principles found in international human rights instruments and in the SDGs. For more information see: https://www.jus.uio.no/smr/english/about/id/equality/index.html To do this we cooperate with academic institutions, professional groups and civil society organisations in Asia to enhance their knowledge and practical capacity to meet with different aspects of unequal and discriminatory treatment.

We take an intersectional approach to discrimination and in 2020 we will organise a workshop on disability and SOGI issues for Asian civil society organisations and we will publish a book on disability and gender. We will be involved in trainings for Chinese human rights teachers on gender and human rights and we will publish a Chinese textbook on gender and human rights. We will be involved in trainings on anti domestic violence in China and we will develop a new large project on domestic violence against people with intellectual disability across Asia. We will also receive guest researchers and participate in conferences and seminars with our partners and arrange lectures and visits during the year.

We seek 2 motivated students who are particularly interested in equality and non-discrimination issues, one for spring 2020 and one for fall 2020 (please remember to indicate clearly in your

application whether you prefer spring or fall semester!!). Tasks will include desktop/background studies/ data collection, organising international seminars or visits, project planning, report writing and general participation in ongoing activities. Interns might also learn how to update and develop our web pages and may be asked to help with other tasks. There might be a possibility to travel to Asia with the project during the internship, but this cannot be guaranteed.

1.3 Human Rights Education (1 internships available)

The NCHR works with human rights education (HRE) to contribute to the effective implementation of human rights standards for all without discrimination. For a period of more than 20 years, we have worked in China and Southeast Asia to improve access to good and quality ensured human rights knowledge and skills, to build capacity of academic institutions and other actors in human rights education and to promote universal respect for and observance of all human rights through gender-sensitive education and applied research. We offer courses and tuition in human rights, train the university lecturers in teaching human rights, help build HRE competence at research institution, government agencies and civil society in several countries.

1.4 NCHR Intensive course in human rights (1 internship)

This is an annual course held approximately the second week of September. Basic tasks include:

1.5 Rule of Law/Anti-Torture and Police Reform (1 internship)

Here, there is work across several countries with the aim of improving the human rights compliance of police forces, preventing torture, and averting wrongful convictions, through the introduction of a non-coercive interrogation technique known as "investigative interviewing". In addition, we work through multilateral channels with the developing global standards for police interviewing. A project aimed at UNPOL is also in the pipeline. The intern will participate in ongoing programme activities related to the abovementioned topic such as preparing and co-organising project activities (events), report writing and/or editing, developing teaching materials, web-based communication, as well as other administrative and relevant tasks. 1.6 Business and Human Rights (1 internships available)

The growing research and impact of business enterprises have given rise to a debate about the roles and responsibilities of such actors with regard to human rights. Through the capacity building and educational initiatives in cooperating with our partners, NCHR works to increase respect for human rights in business activities and strengthen rights and management of local resources. From 2020, NCHR will develop several new projects in this field to build academic competence to teach and research business and human rights, to promote the understanding of importance on business and human rights both for the decision making level and the business sector.

There will be one available internship in 2020. The intern will provide general support in ongoing programme activities, such as organizing seminar, supporting international visit, collecting relevant background information and write background report related to business and human rights. 1.7 Freedom of Religion or Belief (2 internships)

We seek 2 motivated students who are particularly interested freedom of religion or belief issues, one for spring 2020 and one for fall 2020 (please remember to indicate clearly in your application whether you prefer spring or fall semester!). Through the Oslo Coalition on Freedom of Religion or belief (OC), SMR focuses on the root causes of violations of the right

to freedom of belief and belief (FORB) and develops solid, relevant and balanced knowledge as a basis for dialogue and cooperation on new life and religious discourses. This allows for substantial promotion of FORB, which is a politicized and controversial field, with different approaches that may also conflict with each other.

Over the past twenty years, The Oslo Coalition has developed an approach to promoting FORB as a good for all, across faith and life boundaries, through knowledge and competence building, dialogue and collaboration. The work is based on the premise that all human rights are interconnected and indivisible. OC works experts, partners and religious leaders to ensure that projects are defined based on local needs and formulated in a language that best contributes to the promotion of FORB in the given context; whether it is to safeguard women's and children's rights, promote democracy, tolerance and peaceful coexistence, protect vulnerable groups and minorities, or equality before the law.

Tasks will include desktop/background studies/ data collection, organizing international seminars or visits, project planning, report writing, and short text for web publication and general participation in ongoing activities. Interns might also be asked to help with other tasks.

Until 31 December 2016, NORDEM was based at the Centre, but it was transferred to the Norwegian Refugee Council as of 1 January 2017. NORDEM's main objective is to enhance the capacity of international organisations working in these fields – such as the OSCE, the UN and the EU. The tasks of the interns may include supporting NORDEM in arranging pre-mission briefings: identifying thematic/country experts relevant for the assignment and collect relevant background information on the political/human rights situation in the country of assignment; assisting in the deployment process of personnel to election or human rights missions with the OSCE, the UN, the EU or other organisations; assisting in arranging human rights and election observation trainings or seminars; and providing general support to the NORDEM secretariat. 6.1 Centre for Applied Legal Studies/University of Witwatersrand

CALS is a public interest law organisation based at the Wits School of Law. CALS is also a law clinic registered with the Legal Practice Council. As such, CALS connects the worlds of academia and social justice. CALS adopts an intersectional approach to rights protection, understanding that human rights are rarely violated in isolation. The intersectionality of CALS' five Programmes (Basic services, Business, Environmental Justice, Gender, Rule of Law) allows them to address rights violations holistically, responding to the multidimensional nature of human rights violations that are not easily categorised or insulated. For example, the violation of an environmental right usually entails a threat to basic services such as water, housing and sanitation. This threat in turn usually manifests differently for women and men, requiring an understanding of the gendered nature of the violation. A lack of basic services often triggers the need to protest, which is regularly criminalised, resulting in the arrest and detention of people living in poverty. It is this comprehensive and holistic approach that CALS adopts.

13.1. LOI project – Team of 3 students

In 2020, the Human Rights Committee (HRCttee) will roll-out a Permanent Review Cycle (PRC) for 2020-2027 during which it will review all State parties to the ICCPR. It is in anticipation of the special challenge of formulating List of Issues (LOIs) in 2020, that the LOI project will take place. The project would involve research work by a total of 10-12 law students from four Universities: Pretoria, Oslo, Columbia and Hebrew, supervised by four university professors who are current or former members of the HRCttee: Christof Heyns, Gentian Zyberi, Sarah Cleveland and Yuval Shany (project coordinator). The students, preferably with a legal background, will participate in the project between late January to June 2020. If needed, the

project will be renewed, possibly with a new cohort of students, in September-December 2020. The work of the students could constitute part of their clinical education or internship in their respective universities. Each team of students will be required to prepare an LOI dossier for some of the countries targeted for preparation of LOI in 2020. The participating students will undergo in January an online training session, offered by the supervising professors and members of the HRCttee secretariat. Their work will be supervised by their home university supervisor, and the project coordinator. The aim of the LOI project is to facilitate the preparation of LOIs drafts by the HRCttee secretariat, by undertaking a significant part of the preparatory work needed for drafting such documents. The work will be based only on publicly available sources.

Type of work: Joint project with three other universities and the UN Human Rights Committee Secretariat (OHCHR): **3 students, preferably with a legal background.**

13.2 UN Human Rights Committee Factsheets Project - Team of 2 students

Developing legal materials about the work of the UNH Human Rights Committee. Factsheets on precise issues dealt with by the Committee, presentation based on topics (migrants, detention, deportation, death penalty, women's rights etc.) and not on Articles of the ICCPR (at least not initially). A factsheet would present from a neutral and objective perspective the views (summary of the facts and legal position of the Ctee). Based on the cases registered in 2017, 2018 and on the cases discussed during our 125th session, the first factsheets may be on deportation (with sub-categories?), statelessness, enforced disappearances, sexual violence, arbitrary deprivation of life... Some may also be on procedural issues (quality of victim, exhaustion of domestic remedies, abuse of right...). The work of the students will be supervised by Gentian Zyberi and Hélène Tigroudja, members of the UN Human Rights Committee.

Type of work: Joint project with another university (Faculté de droit et de science politique d'Aix-en-Provence), the CCPR Centre (potentially), and the UN Human Rights Committee Secretariat (OHCHR): **2 students. Preference for students who speak and understand both English and French.**

13.3 Monitoring the impact of the UN human rights treaties worldwide: Case of Norway - 1 student

This is a proposal to establish a long-term project aimed at understanding and enhancing the impact of the UN human rights treaty system on the domestic level in all countries in the world. The project will assemble and make available the evidence on the influence – or lack thereof – of the system (the nine main treaties, and the findings and recommendations of the treaty bodies) on the ground. The aim is to allow evidence-based analysis by researchers worldwide of the trends, and the drivers and inhibitors of impact, of the treaty system, allowing them to answer questions such as the following: "What is the real benefit of the treaty system?" and "How does it work in practice?" The project will be undertaken by a consortium of research institutions and NGOs worldwide with expertise in this field, working with reporters based in the various countries. It will be administered from the University of Pretoria. It is envisaged that the project will eventually cover all 193 UN member states and other territories. The project will be developed organically. The most comprehensive study yet conducted into treaty impact is the

one lead by the signatories to this proposal, Christof Heyns and Frans Viljoen. They are currently coordinating an independent academic study, in collaboration with the Office of the High Commissioner for Human Rights, into the impact of the treaty system. This study is due for completion at the end of 2019/beginning of 2020. They are working with 20 researchers who are based in as many countries, who use a common template to obtain comparable information about impact in a number of areas such as the constitution, the laws, court cases, policies and other practices in the country concerned. The work will be supervised by Christof Heyns and Frans Viljoen (Human Rights Centre, University of Pretoria, South Africa) and a professor at the Faculty of Law, University of Oslo.

Type of work: Joint project with the University of Pretoria: 1 student. Preference for a Norwegian student, with good understanding of the Norwegian legal system and the domestic human rights protection system.

#14 PRIO

As an intern at the Peace Research Institute Oslo (PRIO), you can expect to perform a combination of research assistant and administrative duties, depending on the needs of the institute. Research assistant tasks involve supporting PRIO researchers in conducting their research on peace, conflict and security, performing basic research tasks such as coding, transcription or literature search. Administrative tasks are assigned either at the institute or departmental level, and may include such tasks as providing web and social media support for the institute or for specific researchers, contributing to organising events such as internal meetings or public seminars, or carrying out managerial tasks for a journal special issue.
