JUS5880 – Financial Market Law and Regulation JUR1880 – Financial Market Law and Regulation

Outline

The title of the course is «Financial Market Law and Regulation». Financial markets play a key role in the economy, which is reflected by a the extensive regulation in different legal disciplines, including international standard setting, EU law and domestic public and private law. The relationship between these disciplines is one of the cross-cutting challenges to scholarship, regulation and legal practice.

The emphasis of the course is on the *principles* that the regulation and regulatory regimes build on. It covers the rules of banks, insurance companies and investment institutions, their products and the markets these are offered in with securities regulation, prudential supervision, and the law of financial services contracts. The course covers requirements for various types of financial enterprises, including licensing/authorisation, organization of institutions and markets and conduct of business rules with investor protection.

The course includes contracts between different types of financial enterprises and investors or customers.

International and European sources and the interplay between national and European rules and supervisory authorities are the main focus for the discussion of the application of the principles.
