1 Exercise: OWL modelling

In this exercise you shall create an OWL ontology. We suggest you use Protégé to do this. (Tip: we had the best reasoning response using Pellet or FaCT++, and not HermiT.)

Use resources from the table above to model the statements below. Create a suitable namespace for your ontology, and put all statements in the same OWL file.

Statements:

1. The range of name is xsd:string, and the range of age is xsd:int.

- 2. name and age are functional.
- 3. Every horse is an animal.
- 4. Every animal is a male or a female.
- 5. Nothing is both a male and a female.
- 6. Every warmblooded horse is a horse.
- 7. Every coldblooded horse is a horse.
- 8. Nothing is both a warmblooded horse and a coldblooded horse.
- 9. A filly is by definition a female horse younger than 4.
- 10. A stallion is by definition a male horse of age 4 or older.
- 11. A race horse is by definition a horse which has competed in a horse race.
- 12. Every monté race is a horse race.
- 13. Every monté horse is a race horse which has only competed in monté races.
- 14. A superhorse is by definition a race horse which has won more then 100 horse races.
- 15. You must compete in a race to win a race.
- 16. Every warmblooded horse which has competed in a monté race must be between 4–12 years old. (Tip: you might need to use the "general axioms" part of the "Active Ontology" pane in Protégé to express this statement.)
- 17. Every race horse has a name.
- 18. name is a key for race horse.
- 19. Every race horse has at least one trainer which is a person.
- 20. Every person has a name.
- 21. If a horse has a trainer, then this trainer trains the horse.
- 22. Every trainer had interest in a race if a horse he/she trains competed in this race. (Tip: use property chains.)
- 23. No person is a horse, no person is a horse race, and no horse is a horse race.

- 24. Every horse has exactly one sire (father), which must be a male horse, and one dam (mother), which must be a female horse.
- 25. sire and dam are properties which relate horses.
- sire and dam are subproperties of ancestor. ancestor is a transitive property.
- 27. Set natural domain and range restrictions to the properties sire, dam, hasTrainer

Add some data about individuals (create suitable identifiers):

- 1. The horse called "Rex Rodney" is a superhorse. Its trainer is "Kjell Håkonsen", and it won the race Elitloppet (in 1986, use the identifier :Elitloppet1986). Its sire has the name "Doctor Rodney".
- 2. :Elitloppet1986 is not a monté race.
- 3. The horse called "Steady, Ready, Go" is a filly and monté horse.

1.1 DL Axioms

Express the statements 3, 4, 5, 13, 14, 15, 19, 21; and the three statements about individuals as DL Axioms, e.g., no. 6: "Every warmblooded horse is a horse" can be written as $WarmbloodedHorse \sqsubseteq Horse$.

1.2 Questions

Answer the following questions with "Yes", "No" or "Unknown", and a sentence or two to back up the claim, referring to the axioms you have created in your ontology as arguments.

- 1. Is Rex Rodney a male or a female animal?
- 2. Does Kjell Håkonsen have interest in Elitloppet 1986?
- 3. Is Rex Rodney a warmblooded horse?
- 4. Is Steady, Ready, Go a warmblooded horse?
- 5. Is Steady, Ready, Go a coldblooded horse?
- 6. Did Steady, Ready, Go compete in Elitloppet 1986?

2 Exercise: Mapping dbpedia to your ontology

The task of this exercise is to create a mapping of parts of the dbpedia vocabulary about horses and race horses to your ontology from the exercise above.

Below is an excerpt from the result of running a DESCRIBE query¹ on the dbpedia.org SPARQL endpoint: http://dbpedia.org/sparql. The excerpt contains data about two race horses, one of them is listed below, a race horse called "In the Wings". The exercise is to create a mapping ontology which maps all properties mentioned in the excerpt to the ontology you created in the exercise above.

The mapping shall be created by giving a series of axioms (i.e., subclass/-property and equivalence axioms) which relate the dbpedia properties to your classes and properties, e.g,

dbpprop:dam owl:equivalentProperty :dam

creates a mapping between the dbpprop:dam and "your" :dam property. Note that the lefthand- and righthand-side of the axioms can be complex classes or properties, e.g., dbpprop:horsename should be mapped to some combination of :name and :Horse (not only to :name) (Tip: you need to use the general axioms feature in Protégé to express this.)

Your mapping ontology should be a separate file and it should import the ontology at the above address from this address and additionally the ontology you have made in the first exercise.

Notes:

- In the properties dbpprop:m, dbpprop:fm, dbpprop:mm, and so on, m means "mother" and f "father", so two letters means a grand-parent, e.g., dbpprop:fm is the mother to the father (norwegian: farmor) to the horse.
- In the excerpt dbpedia:Stallion is an individual (and not a class).
- If the intended meaning of the properties or other resources in the excerpt is not clear, use a reasonable interpretation you find fit.
- Since you will be working with resources from different ontologies, keeping them apart is smart. To display names in Protégé using qualified names enable the setting found in Protégé under the File -> Preferences -> Renderer -> "Render by qualified name".

2.1 Questions

Apply reasoning to your ontology and answer the following questions:

- 1. List all stallions.
- 2. List all male horses.
- 3. Since "Northern Dancer" is an ancestor of "In the Wings", the ancestors of "Northern Dancer" should also be the ancestors of "In the Wings". Why is this not the case?

3.1 Punning

In oblig 5, you learnt that the official RDF semantics gives a meaning also to triples where the subjects and objects can be classes or properties. This is not supported by the "DL" semantics however, and indeed, non of the reasoners connected to Protégé are able to deal with ontologies where individuals, classes, and properties are not clearly separated.

Still, it is possible to load such ontologies into Protégé, based on a mechanism called "punning," see http://www.w3.org/TR/owl2-new-features/ #F12:_Punning.

Let Γ_3 be the ontology listed below, using Manchester syntax for brevity. A turtle variant is listed in the appendix.

An OrderOfMammals is an OrderOfAnimals whose members must be Mammal-s. Since Elephant is a subclass of Mammal, which is a (, i.e., has type) OrderOfMammals, one could expect that a DL reasoner would infer that Elephant is an OrderOfMammals. However, this is not the case. Explain why.

3.2 Annotation properties

In OWL, rdfs:label is a predefined annotation property, see http://www.w3.org/TR/owl-ref/#Annotations. Explain what an annotation property is and why they are useful.

3.3 OWL profiles

For each of the axioms in 1.1 decide if they are "in isolation" a

- 1. valid OWL EL axiom, and
- 2. valid OWL QL axiom.

Here, "in isolation" means that you shall consider each axiom as though it is the only axiom in a given ontology, i.e., you don't have to consider other axioms that the resources may appear in.
